

2010 Business Arts Award Nomination

The Community Medal of Arts was designed to celebrate and commemorate those persons who have made significant contributions to the arts. With this award, we honor those who are actively engaged in the cultural life of this community. Artists, teachers and arts administrators are eligible for this award. Nominees must reside or work in Kalamazoo County. Each year, winners are awarded at a ceremony in their honor, along with the Community Medal of Arts, Theodore C. Cooper Award for Distinguished Volunteer Service and the Young Artist Award. ***In 2010, the event will take place on June 21st, and complete details will be announced as they are available.***

Nomination Process

Member artists, arts organizations and donors of the Arts Council may submit nominations for the Business Arts Award. A complete nomination form will include:

- 1) The completed form
- 2) A one page description of the reasons why the nominee should be considered
- 3) A description of the business's mission/vision/or purpose
- 4) **No more than five recent letters** of support for the nominee

The nominations will be reviewed by committee, and an announcement will be made to honorees once a decision is reached (on or before January 31st, 2010). It is requested that both nominators and honorees do not publicly discuss the names of awardees until such time as a media announcement has been made.

Nominations are due at the Arts Council by 5 pm on November 6th, 2009. All nomination materials must be submitted at the same time.
